### **National Strategy to Combat Human Trafficking**

Sex Trafficking Because commercial sex is already illegal in most locations, it is more likely that law enforcement will encounter potential victims However, victim identification may be hampered because minors may say they are over the age of 18, and adults may conceal the use of force, fraud, and coercion Victims exploited for commercial sex

### **CHILD SEXUAL ABUSE STATISTICS - Darkness to Light**

- Juveniles who commit sex offenses against other children are more likely than adult sex offenders to offend in groups, to offend at schools, and to have more male victims and younger victims<sup>11</sup>
- The number of youth coming to the attention of police for sex offenses increases sharply at age 12 and plateaus after age 14
