In opposition to the positivist fixation on fact-stating modes of discourse, Habermas does not limit intersubjectively valid, or justifiable, claims to the category of empirical truth, but instead recognizes a spectrum of "validity claims" that also includes, at the least, claims to moral rightness, ethical goodness or authenticity, personal sincerity, and aesthetic value (TCA 1: 8-23; 1993, chap. 1).
