The Basin F Interim Response Action began in March 1988 and involved the transfer by tank truck of 4 million US gallons (15,000 m³) of Basin F liquid to three 1.3 million US gallons (4,900 m³) holding tanks and approximately 6.5 million US gallons (25,000 m³) to a double-lined holding pond.
